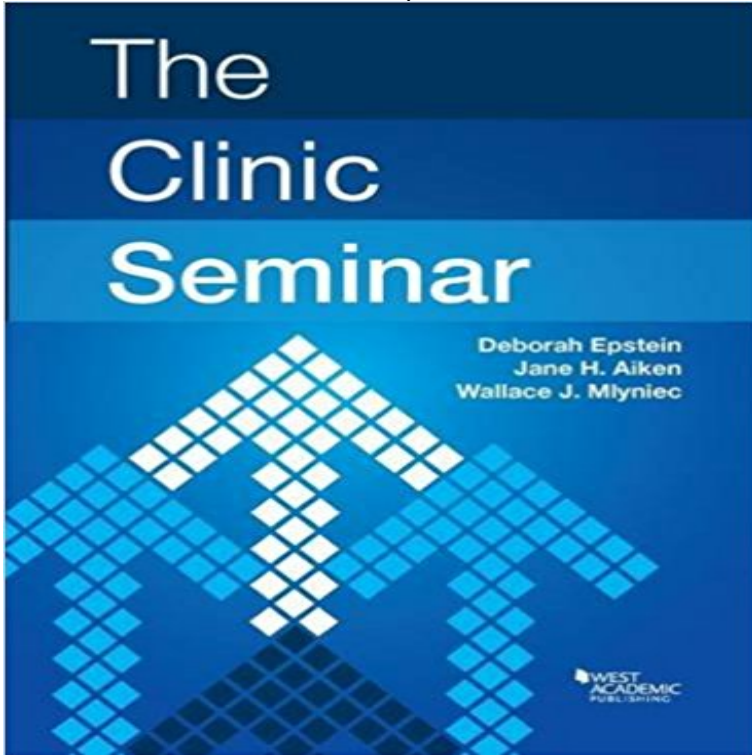


## The Clinic Seminar (American Casebook Series)
