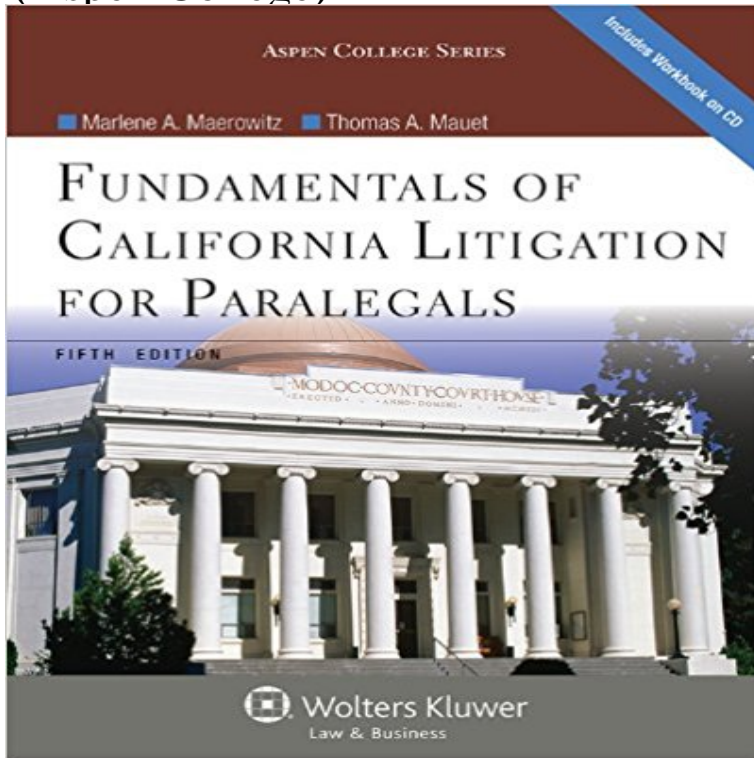


# Fundamentals of California Litigation for Paralegals, Fifth Edition (Aspen College)
