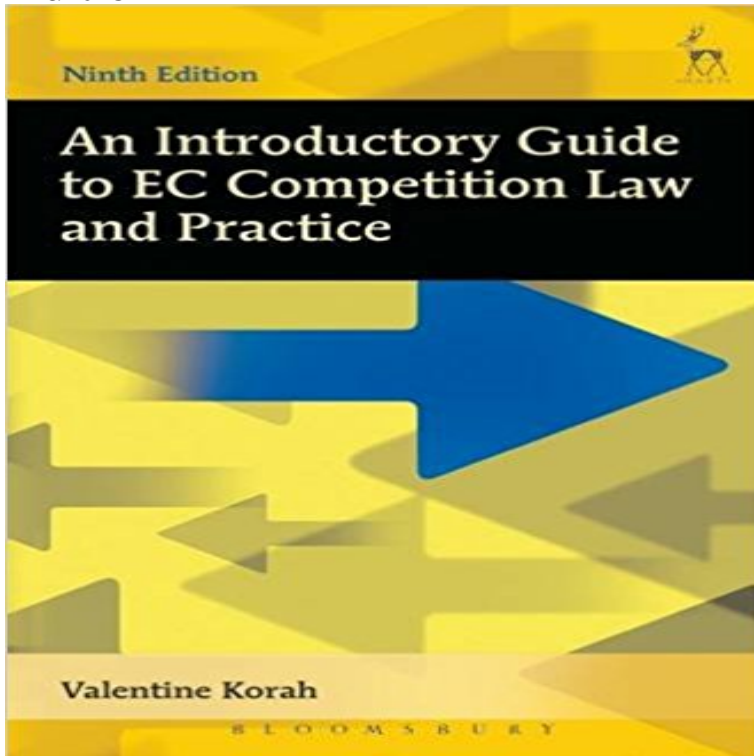


# An Introductory Guide to EC Competition Law and Practice: Ninth Edition
