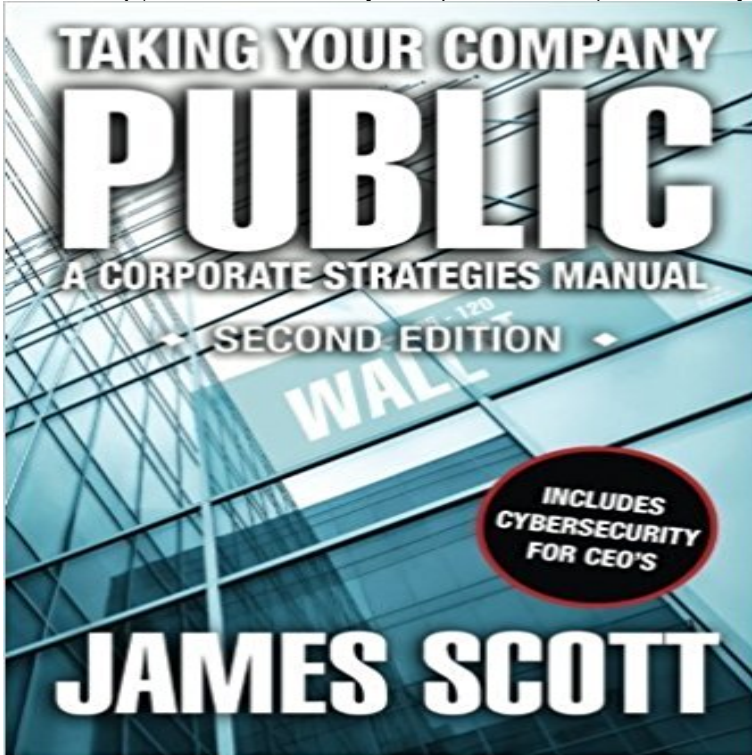


# Taking Your Company Public, A Corporate Strategies Manual
