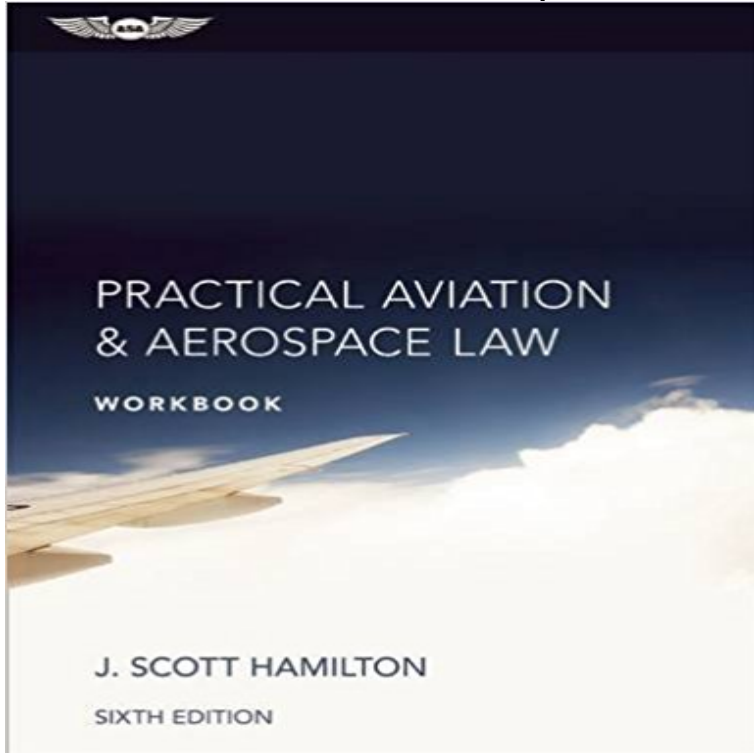


Practical Aviation & Aerospace Law Workbook
