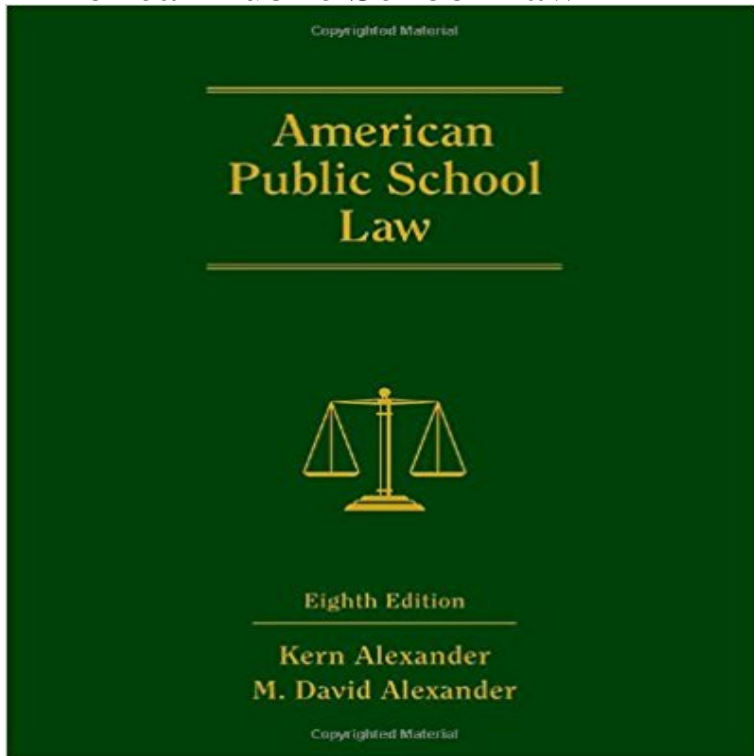

Chapter 1, The Legal System, includes a new section on How to Find the Law (how to do legal research). Each chapter now begins with an introduction section that sets the stage for the material that follows, and concludes with a new Summation of Case Law section that summarizes the key points of the various legal precedents discussed.
