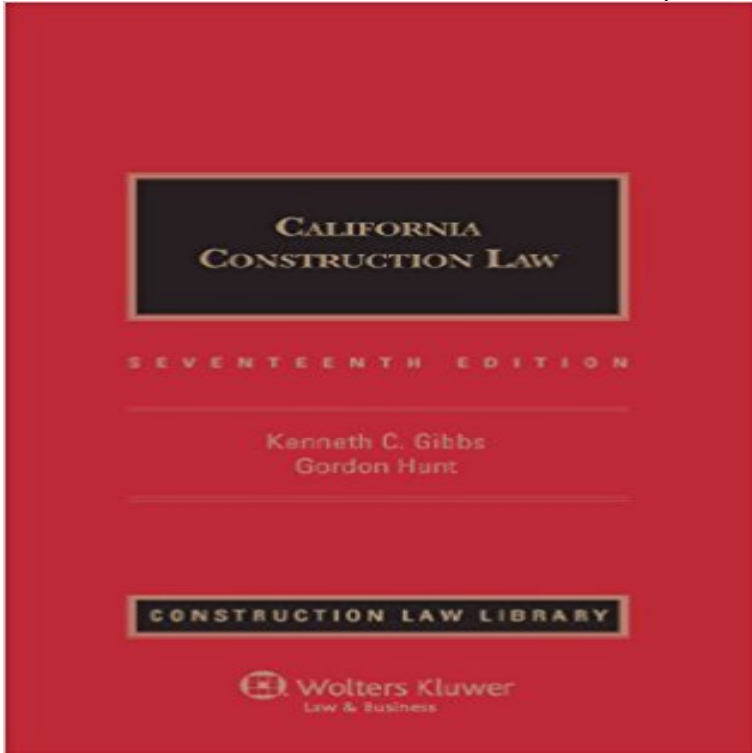


# California Construction Law 17e (Construction Law Library)

Several chapters are then devoted to statutory remedies-mechanics liens, stop notices, and bonds both on public and private works. Finally, coverage is provided on other issues and subjects involving the construction industry, including expanding liability, home improvement contracts, bankruptcy, and alternative dispute resolution.
