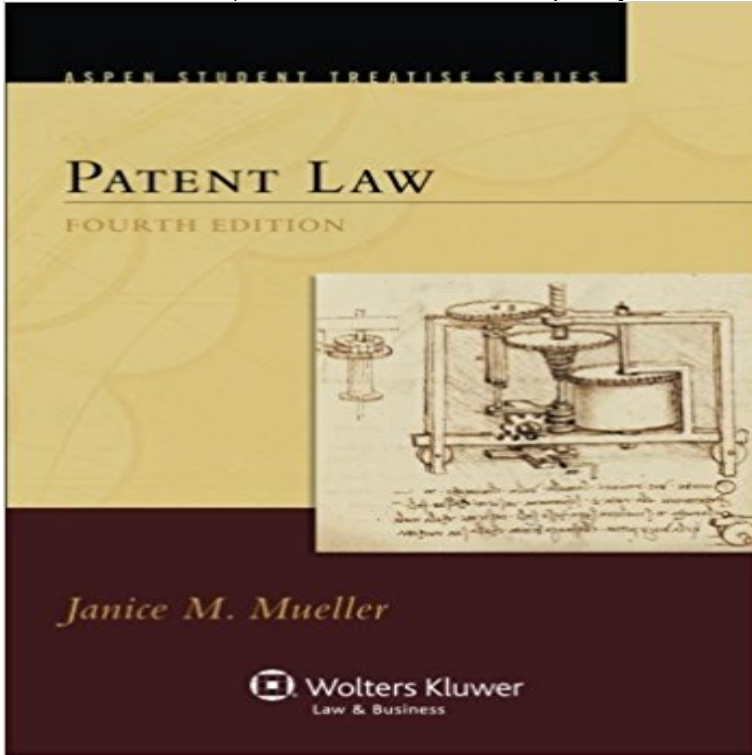


# Patent Law, Fourth Edition (Aspen Treatise)
