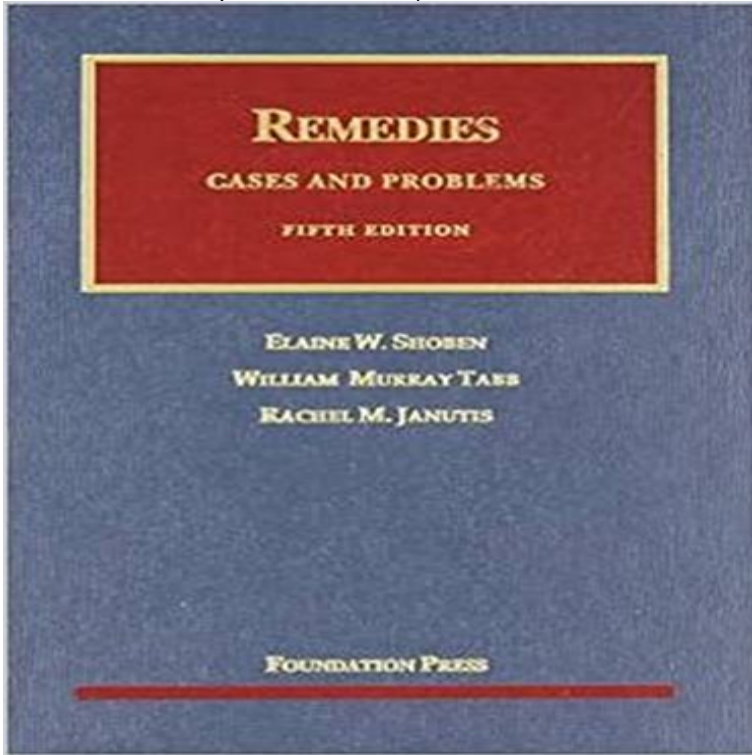


## Remedies (University Casebook Series)
