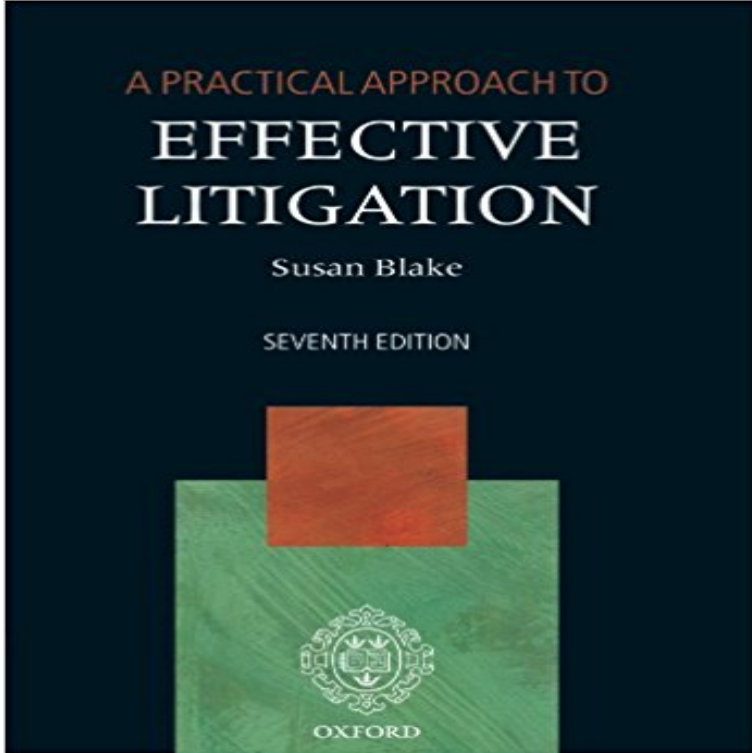


## A Practical Approach to Effective Litigation
