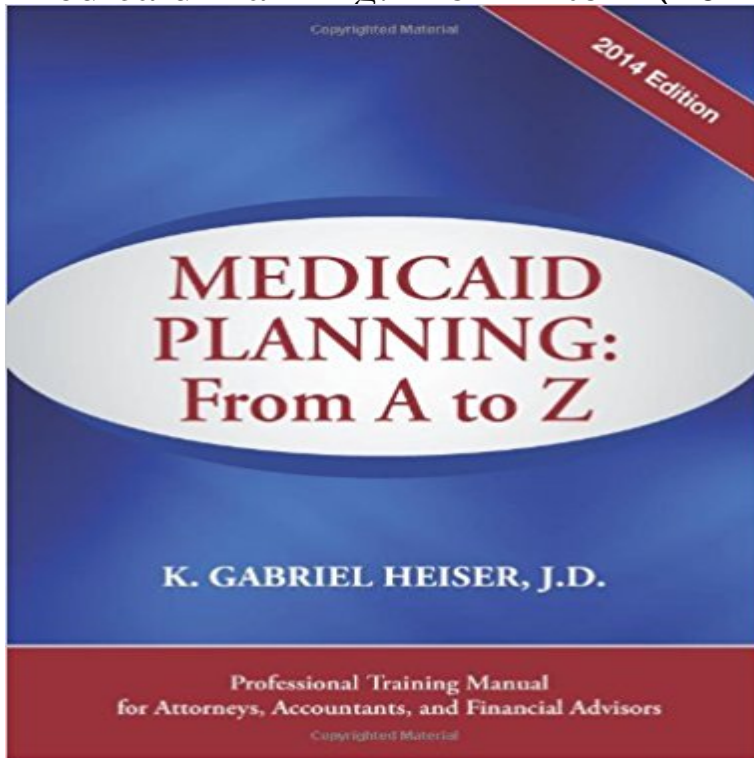


## Medicaid Planning: From A to Z (2014)
