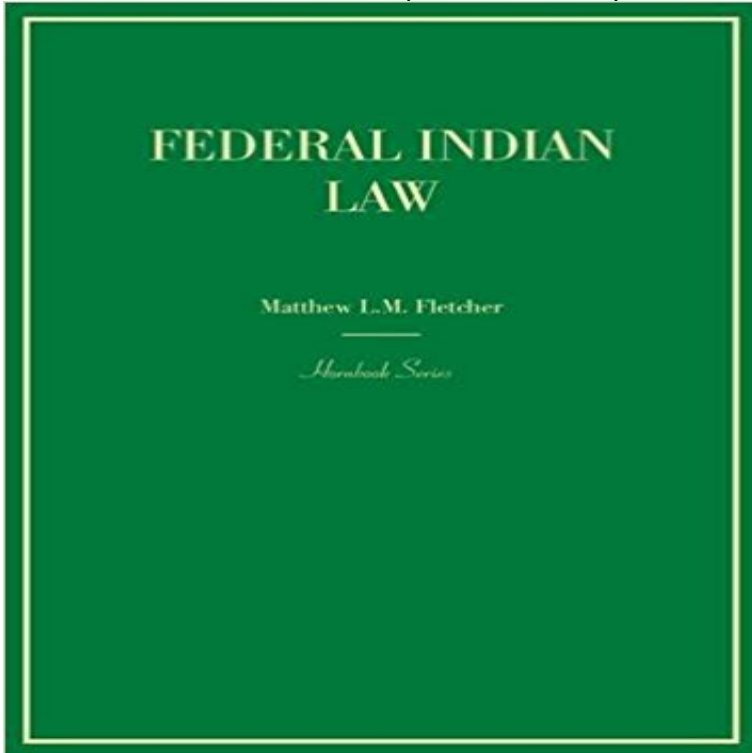


## Federal Indian Law (Hornbook)
