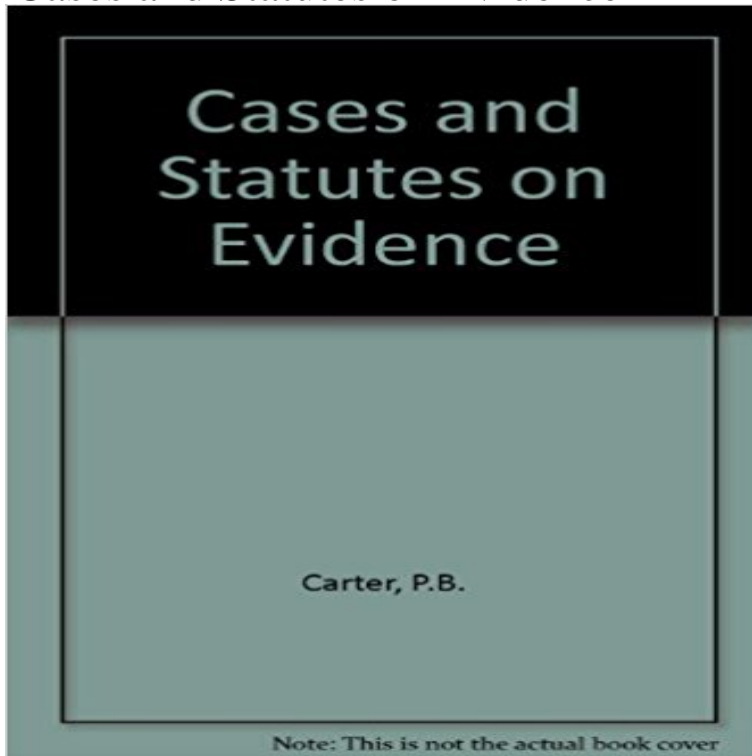


## Cases and Statutes on Evidence
