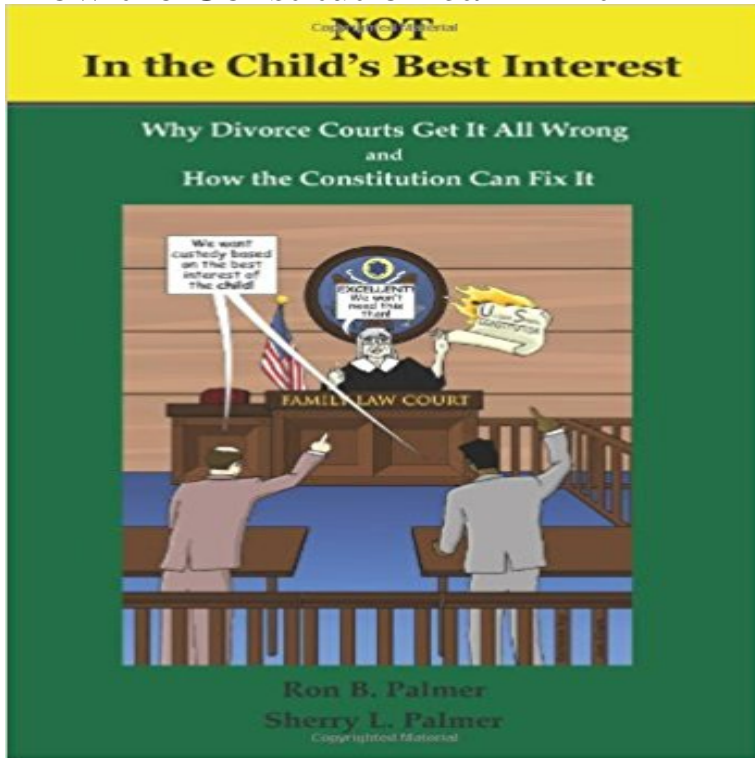


# Not In the Child's Best Interest: How Divorce Courts Get It All Wrong and How the Constitution can fix it
