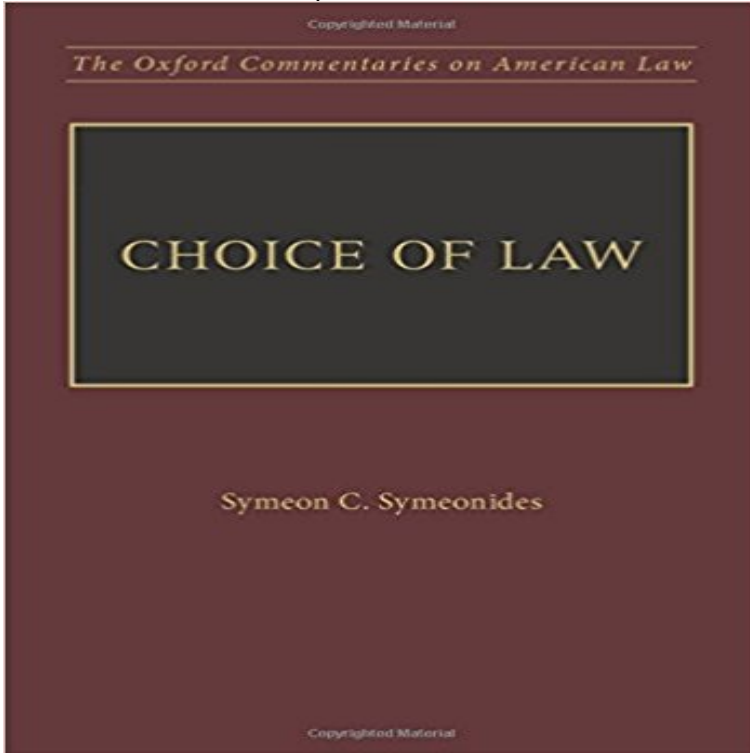


Choice of Law (Oxford Commentaries on American Law)
