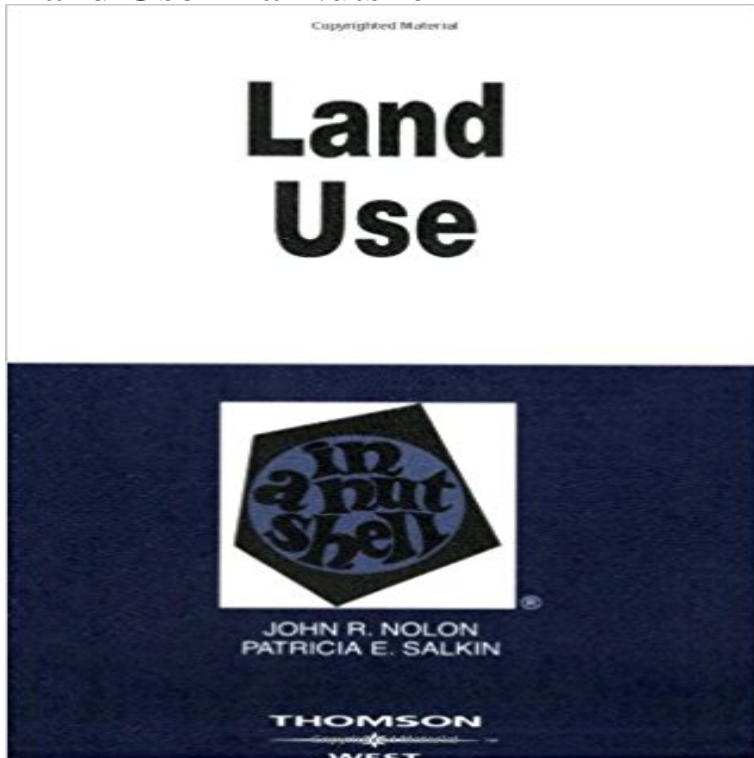


# Land Use in a Nutshell
