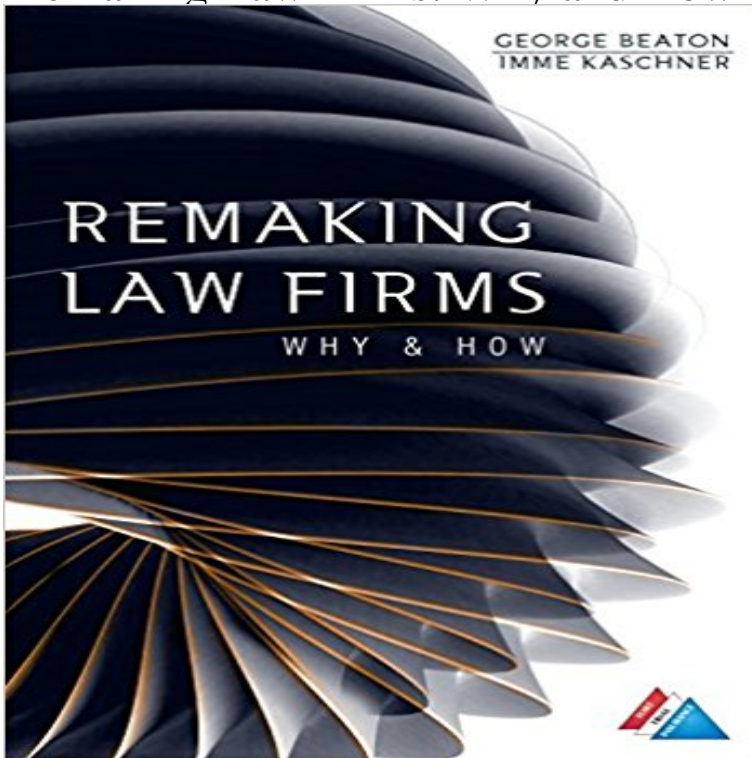


## Remaking Law Firms: Why and How
