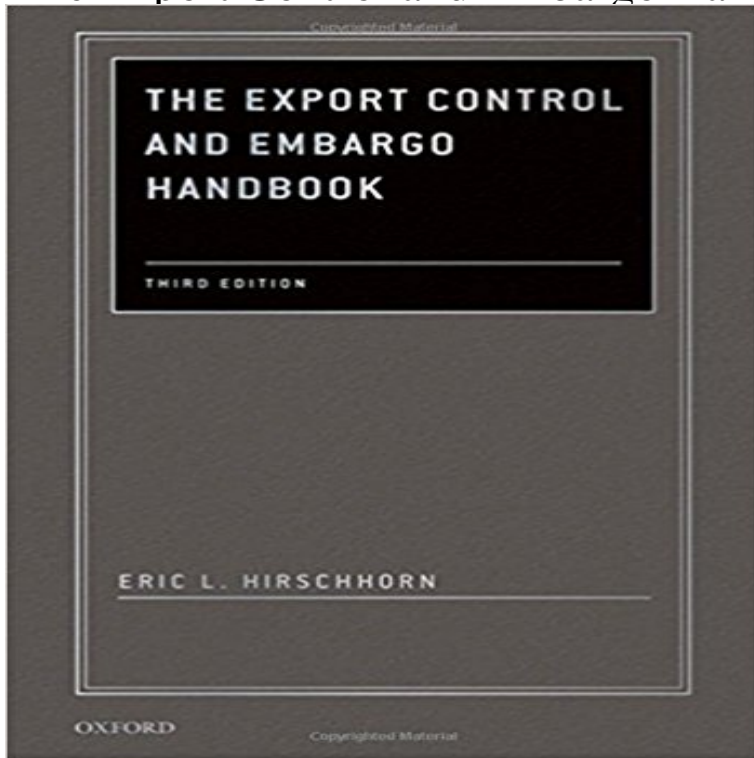


The Export Control and Embargo Handbook
