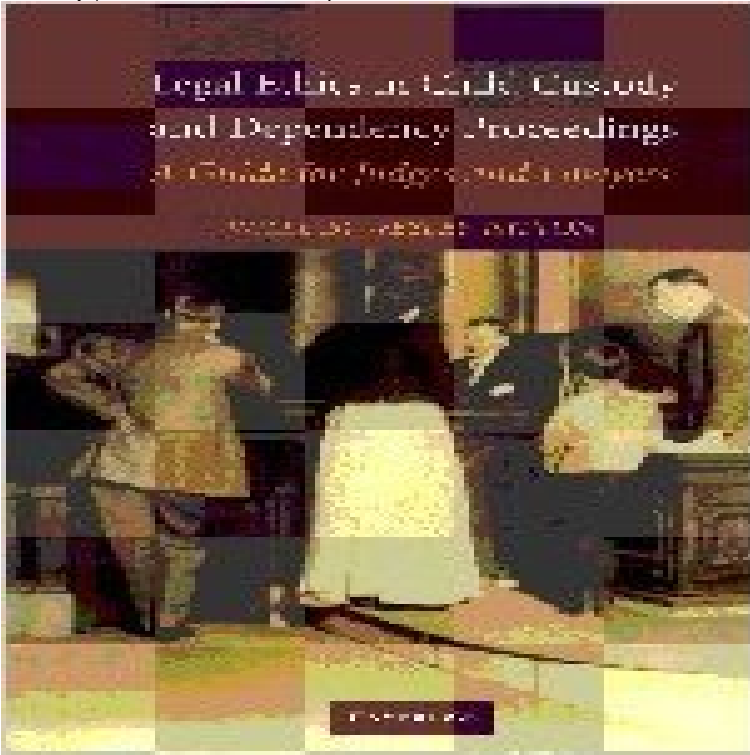


Legal Ethics in Child Custody and Dependency Proceedings: A Guide for Judges and Lawyers
