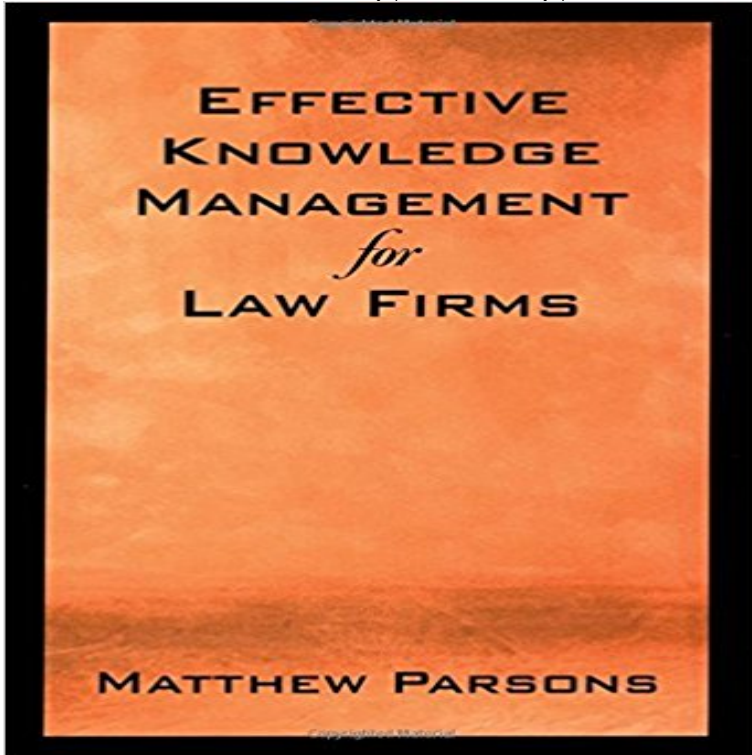


## Effective Knowledge Management for Law Firms
