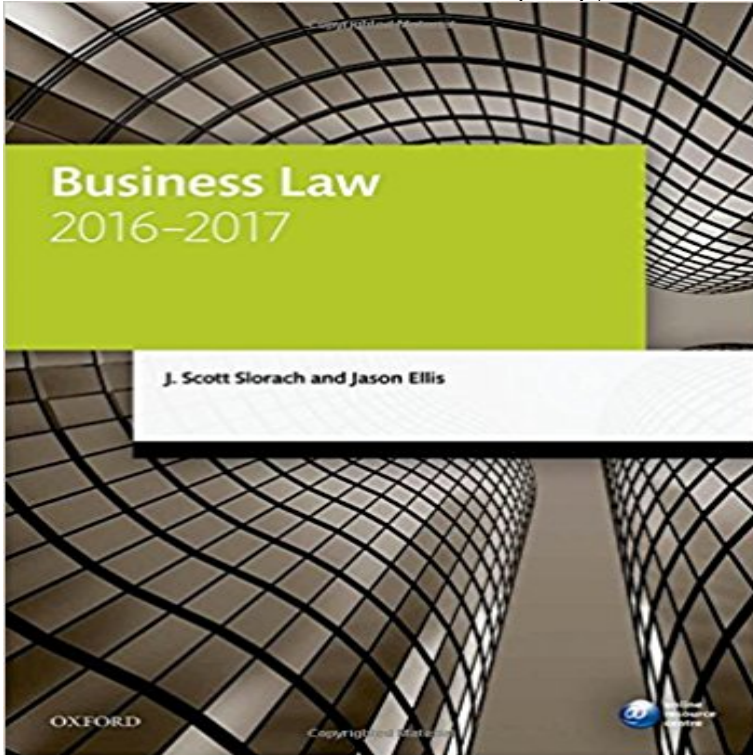


## Business Law 2016-2017 (Legal Practice Course Manuals)
