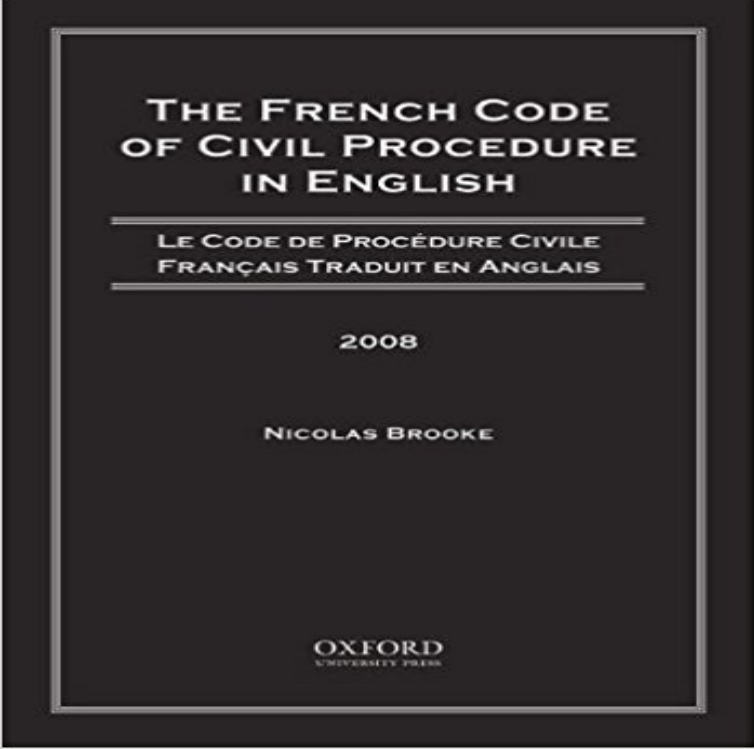


# The French Code of Civil Procedure in English, 2008: Le Code de Procédure Civile Française Traduit en Anglais, 2008

Because the civil code is updated on a continual and regular basis, the current up-to-date version is a must-have for any business or academic institution needing to refer to it.
