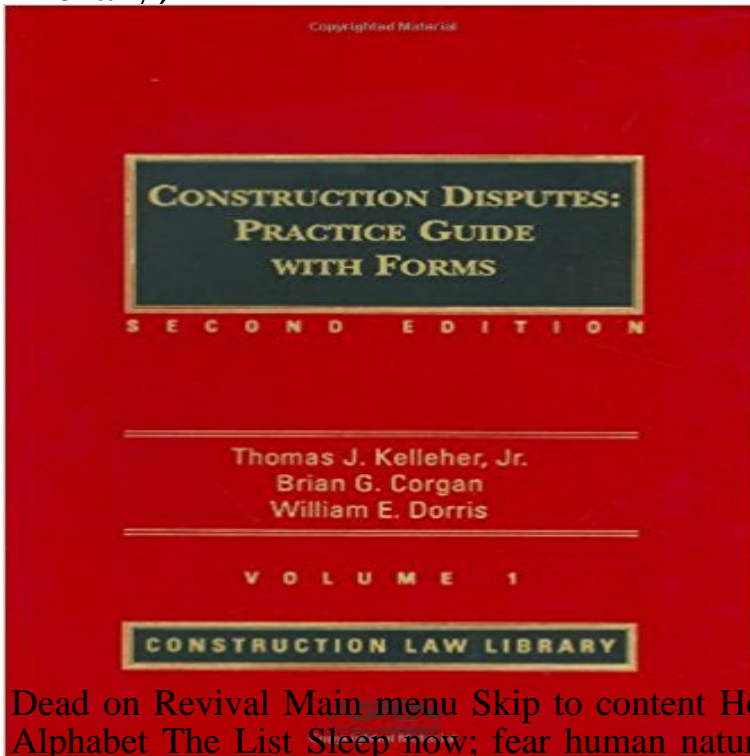


Construction Disputes: Practice Guide with Forms (Construction Law Library)
