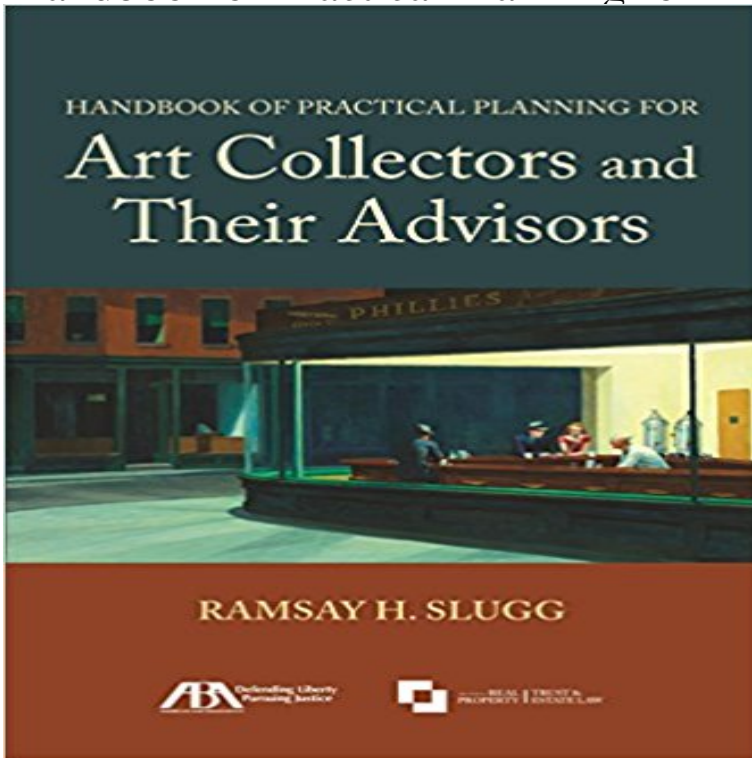


Handbook of Practical Planning for Art Collectors and Their Advisors
