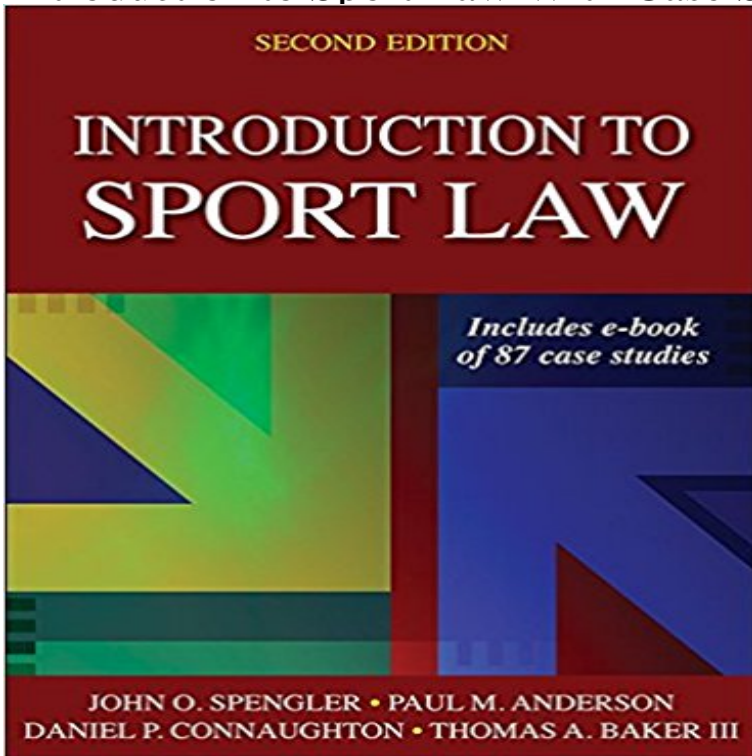


Introduction to Sport Law With Case Studies in Sport Law 2nd Edition
