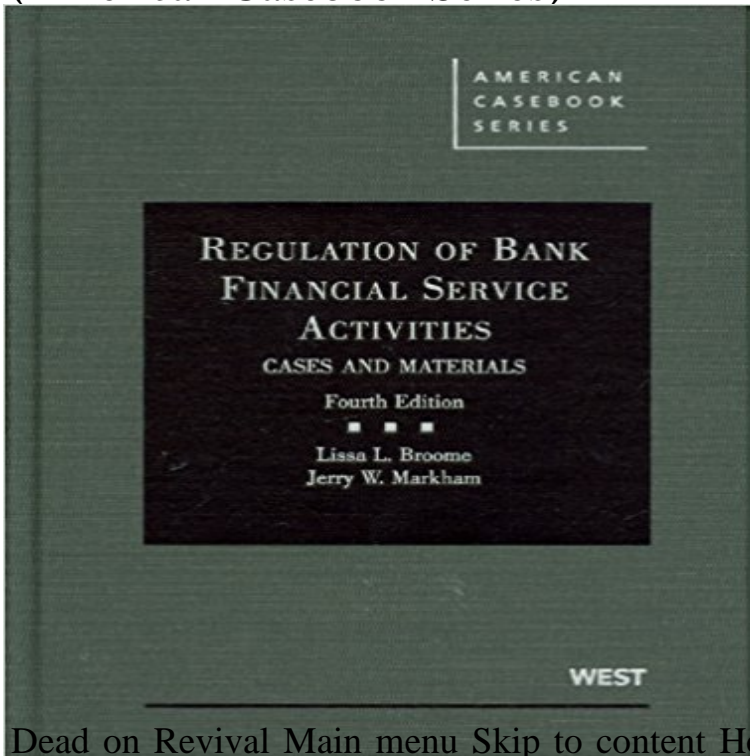


Regulation of Bank Financial Service Activities: Cases and Materials (American Casebook Series)
